OBJECTIVES

The course will use the basic tools of economics to analyze current public policy issues in the United States. Given the time constraints of the course, we will focus on the most significant issues facing the country. The goal is to understand both the substance and politics of each issue. We will examine the effects of recent policy changes and analyze the likely effects of prospective reforms, particularly those that are currently being debated or implemented.

In general, the Tuesday class will provide background on the policy issue at hand. The Thursday class will consist of student presentations and discussion. Given the broad scope of the course, students should expect a heavy reading load.

ASSIGNMENTS

- Quizzes: There will be regular quizzes on the assigned readings. The quizzes may or may not be announced in advance. The quizzes will be drawn from the reading but will also ask you to analyze policy questions based on material covered in the course to date.
- ➤ <u>Group Presentation</u>: Each student will participate in one group presentation. The purpose of the presentation is to brief the rest of the class on a specific policy change related to the week's topic (e.g. 1996 Welfare Reform).
- \triangleright Midterm Exam (7/30): The exam will cover topics and readings through Week 6 of the class.
- ➤ Policy Memo (due 8/6): You will be asked to propose a policy change to be implemented at the state, local, or federal level. Your proposal must require some kind of institutional change, which typically means approval by some government body (e.g. a state legislature, a federal agency, Congress, etc.). The policy memo must identify a social challenge, propose a policy change (or package of changes) to ameliorate that social challenge, and defend your plan using tools from the course. This memo may be rewritten; the final grade will be an average of the first and second drafts.
- Final Exam (8/26): The final exam will primarily cover topics from the second half of the course.

GRADING

The grade for the seminar is made up of the following: quizzes (15%); group presentation (10%); midterm (25%); policy paper (25%); non-cumulative final exam (25%). If you choose to rewrite the policy project, your grade will be an average of the first and second drafts.
